SNC Rate Reduction

EPA will discuss the agency’s efforts to support the new strategic plan goal of reducing the rate of significant noncompliance (SNC) in the NPDES program by 50% (to a national rate of 12%) by the end of FY 2022. EPA recognizes this goal cannot be accomplished without state support and is working directly with states to identify opportunities for making positive forward progress. Over the last year EPA been focusing on continuous improvement through the identification and solving of problems at the levels closest to the work. OW’s currently has 143 different program measures but has a set out to streamline this list and to a core set of optimized measures that can be used to support ELMS, OW’s budget requests, and the National Water Program Guidance process.
