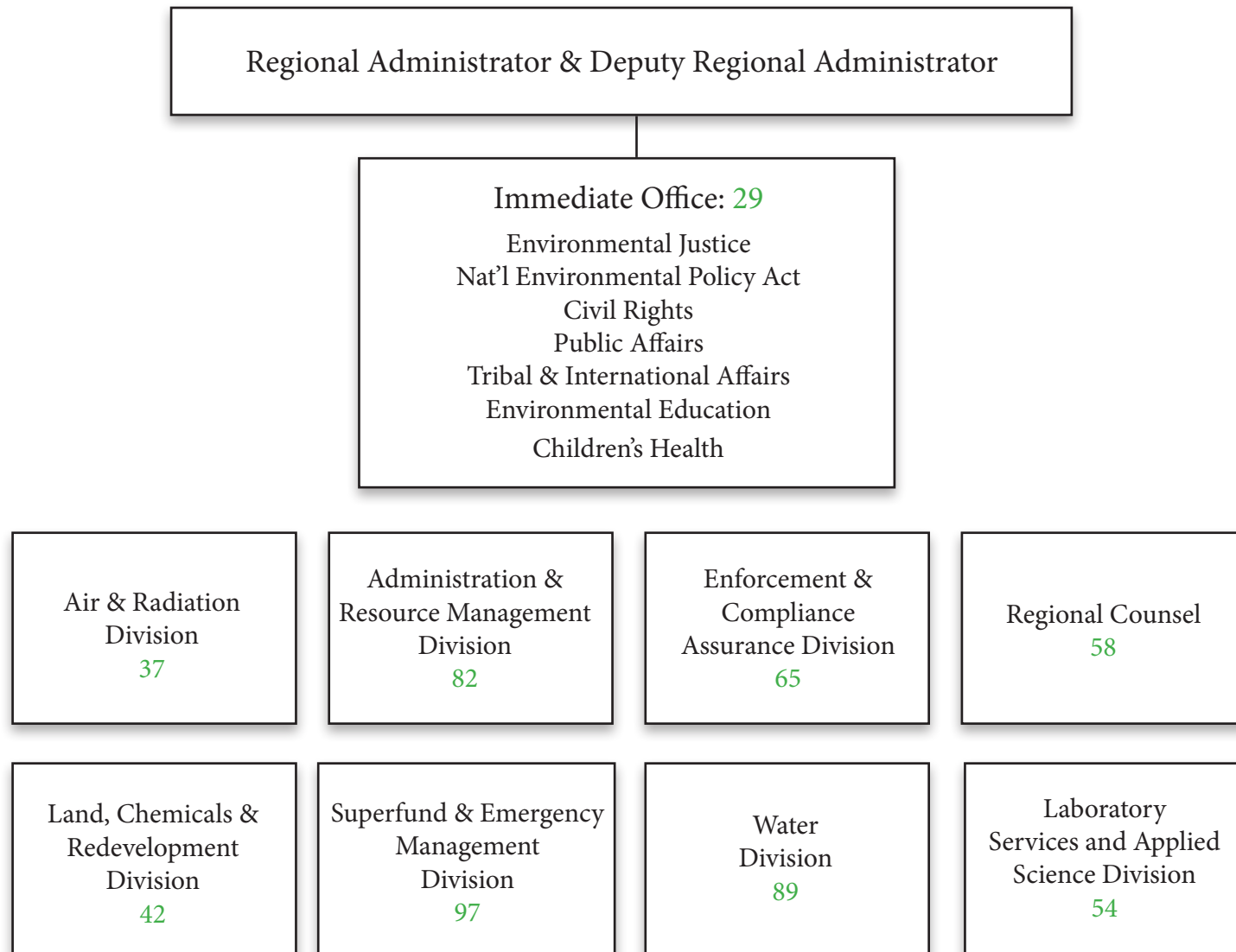

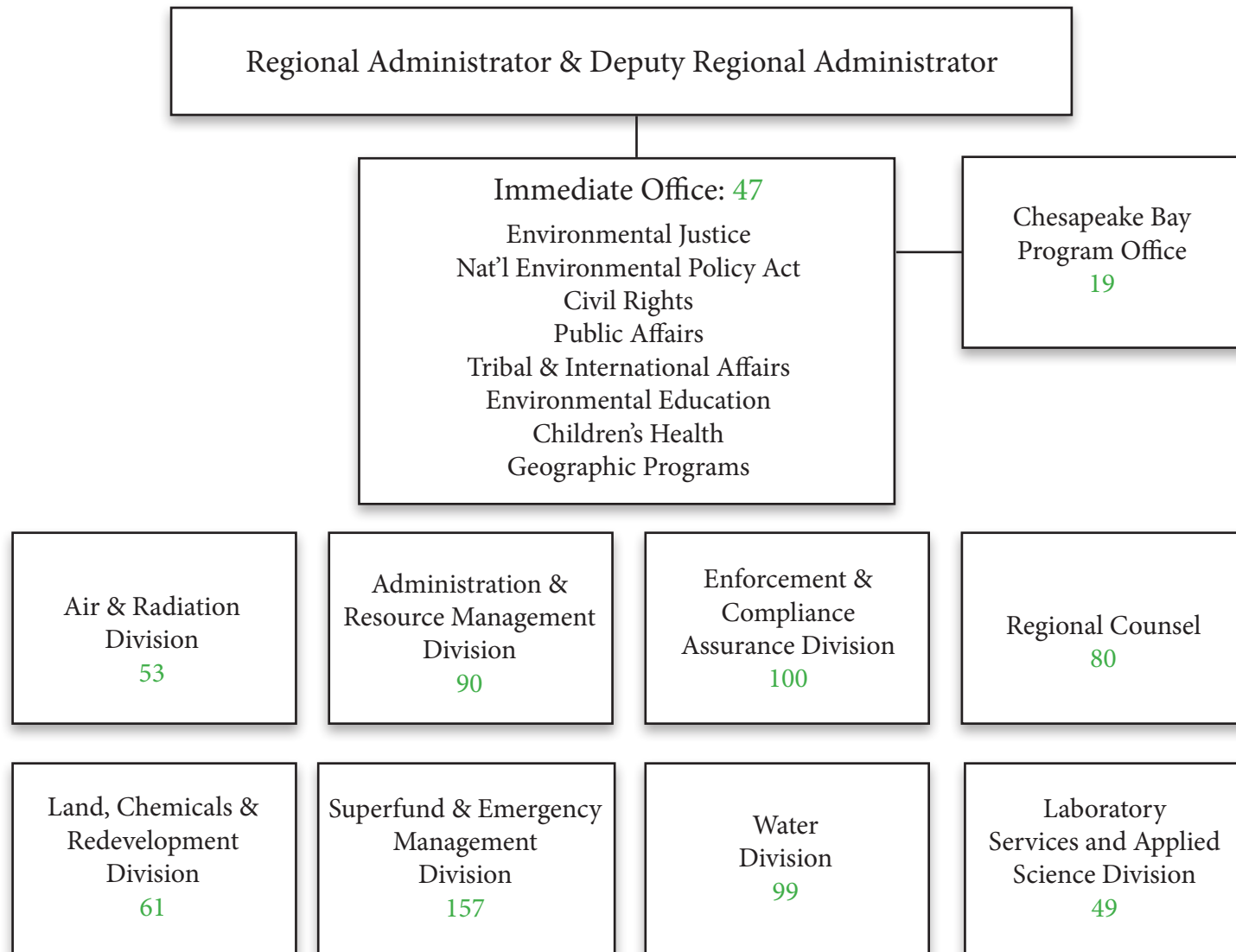

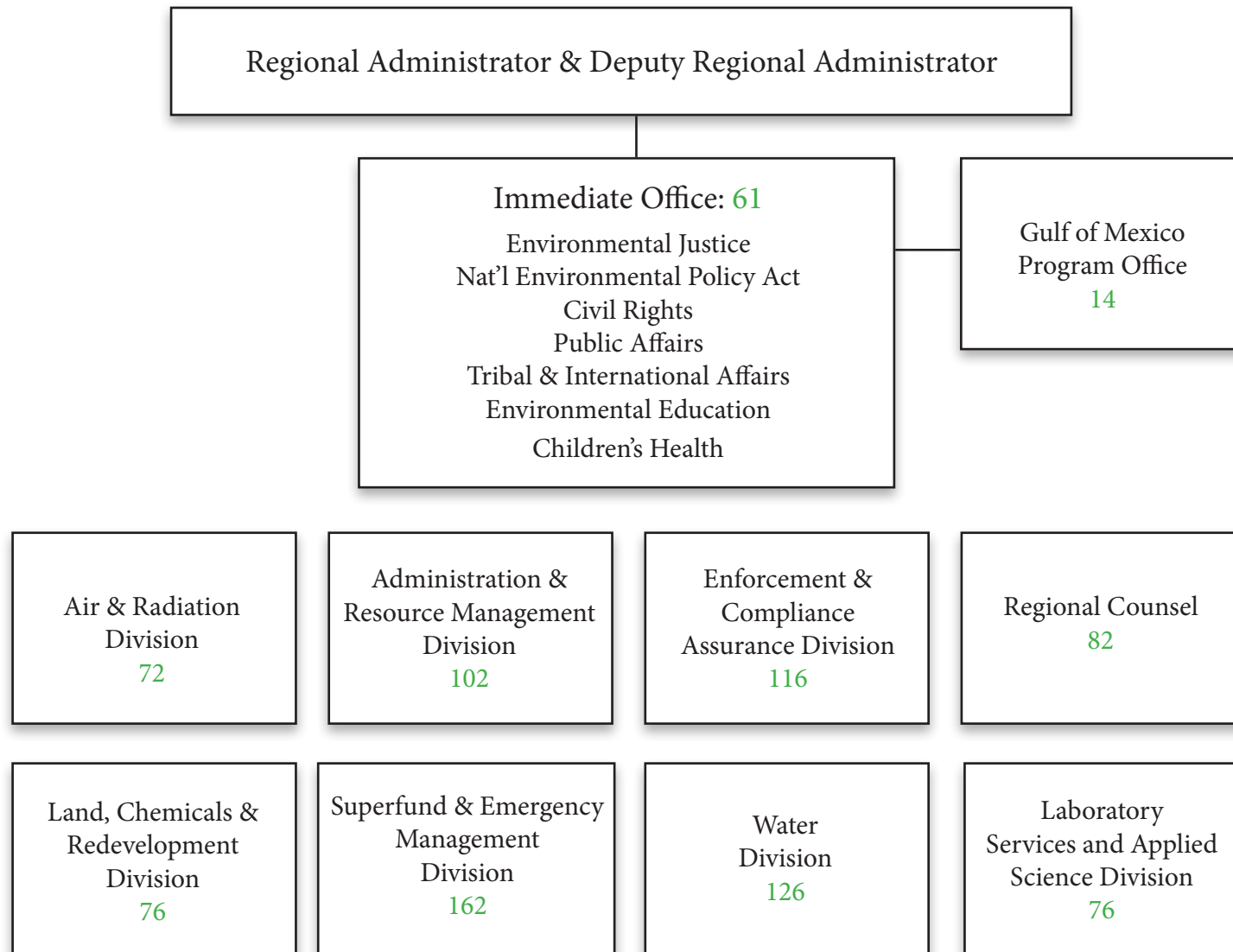
Proposed Organization for EPA's Region 3 Office **755 total positions**

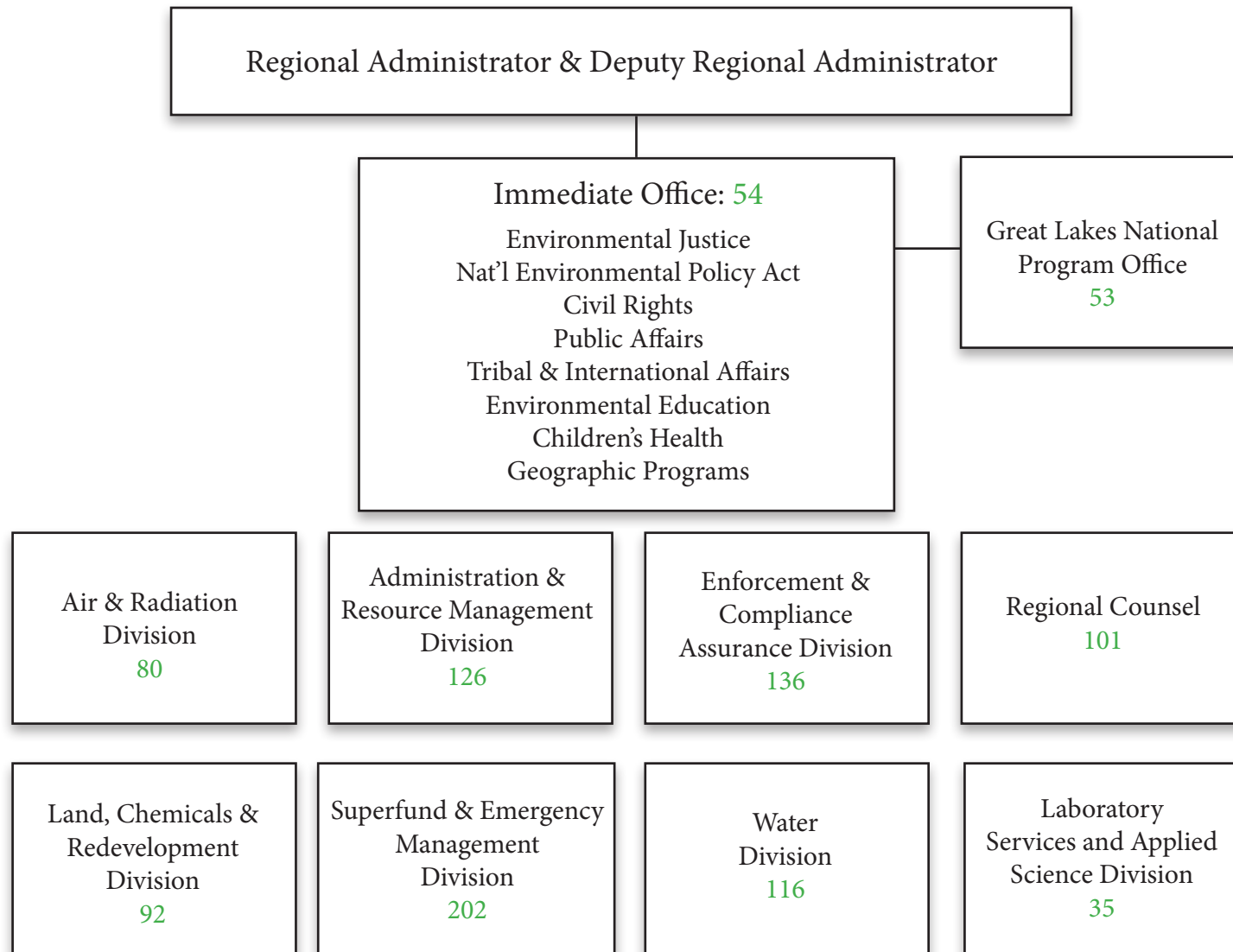

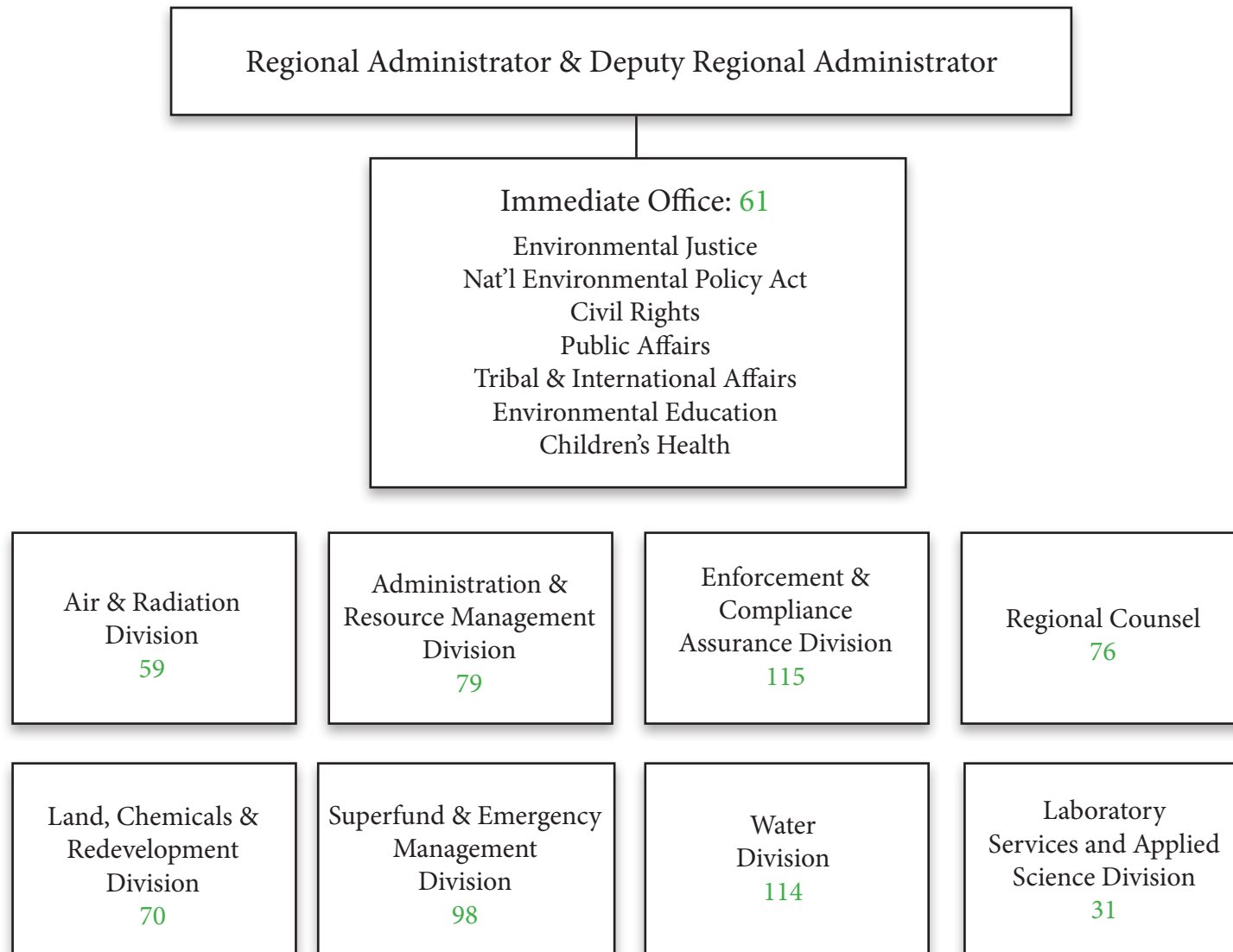

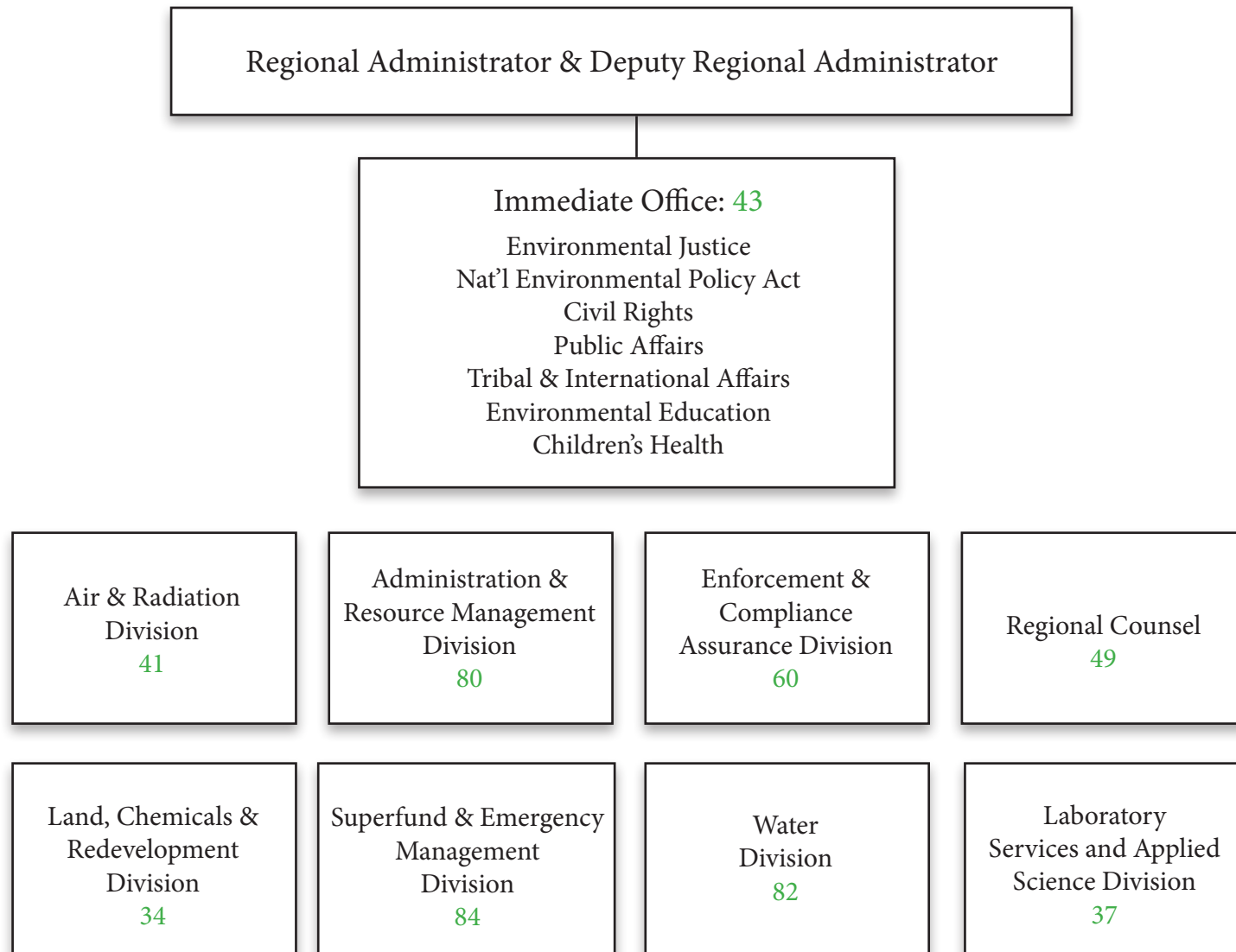
Proposed Organization for EPA's Region 7 Office 484 total positions

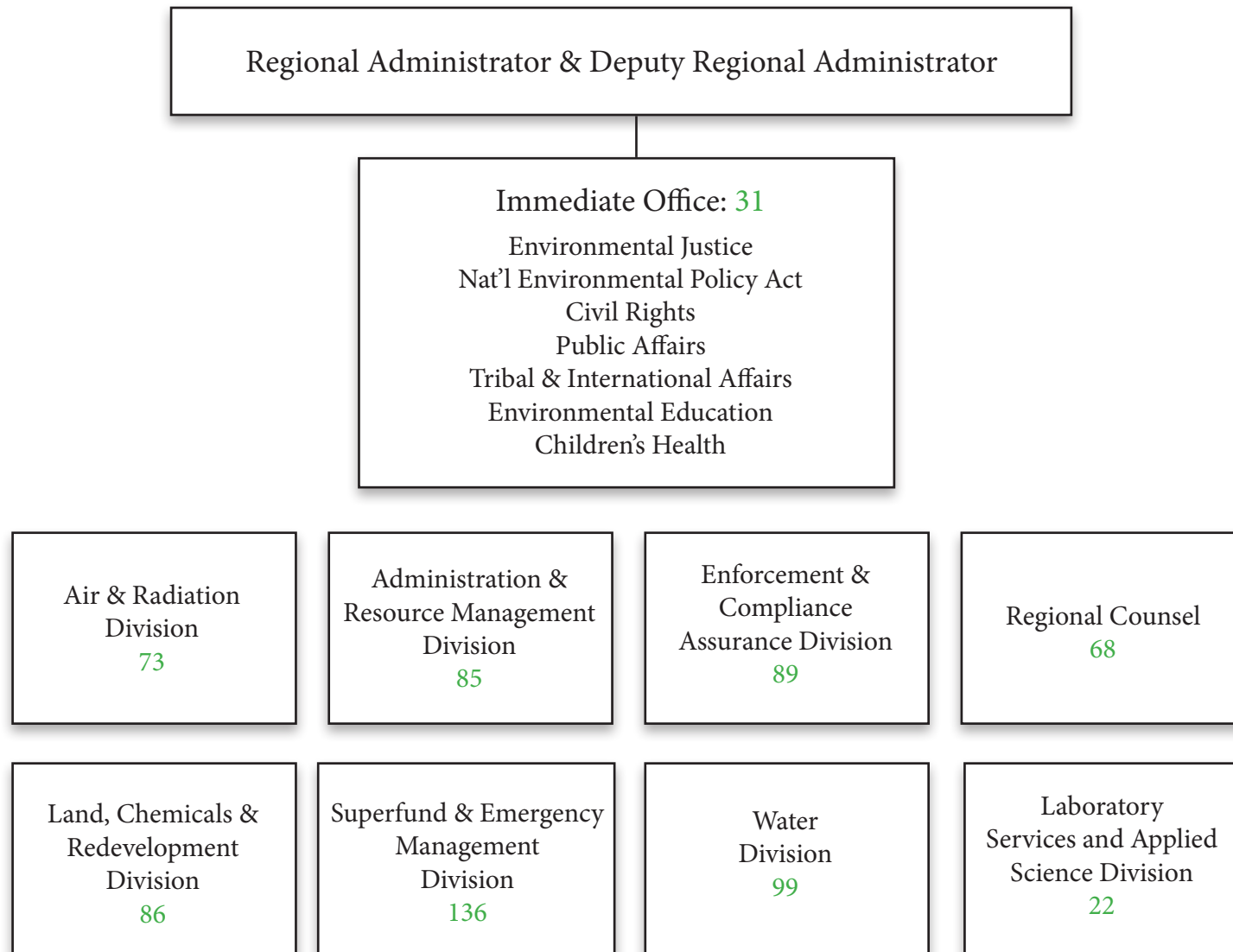

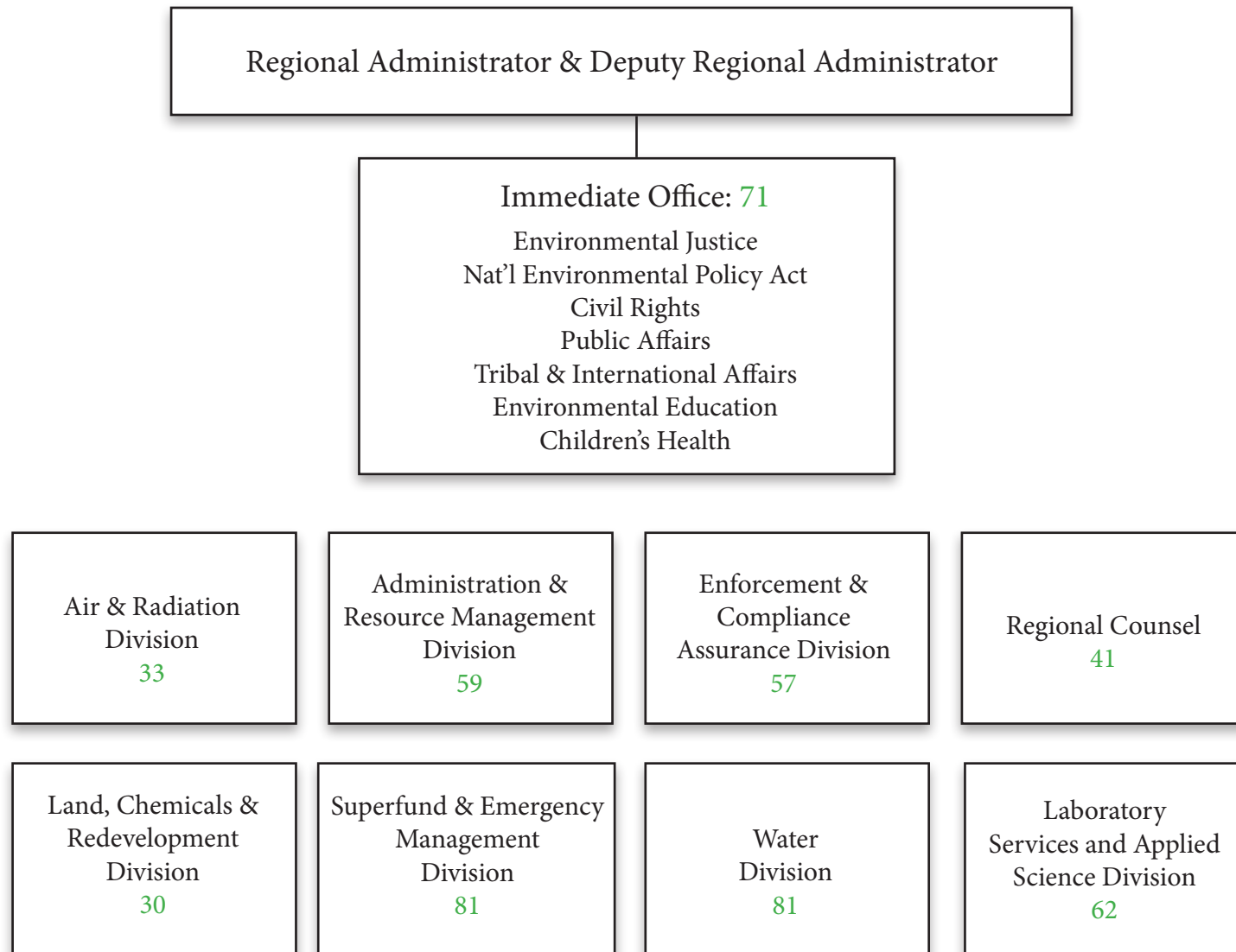
