### **STREAMLINING THE NPDES PERMIT PROCESS**

- <u>What do we do?</u> We, of course, process authorizations to discharge potentially polluted wastewater.
- <u>Individual Permits</u> We issue individual permits for industrial dischargers, municipal dischargers, pretreatment permits (for non-delegated municipalities), equivalent permits and (state-only) groundwater discharge permits.
- Together there are ~ 550 issued permits.
- <u>General Permits</u> We have 9 master general permits Swimming Pools, Hydrostatic Testing, Surface Coal Mine, Mineral Mines, Seafood, Pesticide, Marina, Industrial SW, Construction SW.
- We also issue ISW no exposure certifications and we also have two groundwater only general permits for vehicle wash and composting toilets.
- Together there are ~ 10,000 registrations and certifications covered.




