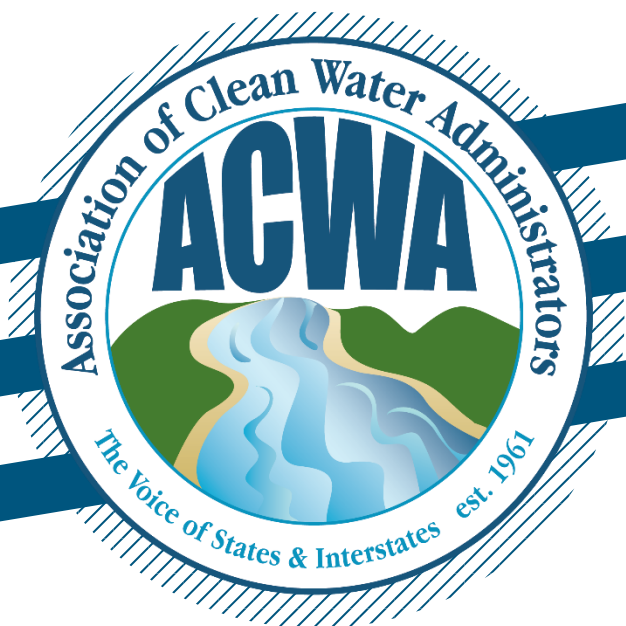
2026 ACWA Fall Clean Water Act Regulators Summit

65th Annual Meeting

**The Eldorado Hotel and Spa
Santa Fe, New Mexico
August 5th – 7th, 2026**

The 65th Annual Meeting brings together surface water quality program directors and senior staff from state environmental agencies and EPA regional and headquarters offices for 2.5 days of structured policy exchange, problem-solving, and federal-state coordination.

The program is designed for state surface water quality program directors, NPDES permit writers, water quality standards coordinators, and their federal counterparts. Participants should expect substantive peer exchange with counterparts from other states and EPA regions, direct engagement with EPA Office of Water policy staff, and actionable takeaways applicable to their home programs. The program addresses the principal policy and operational challenges facing state CWA programs today. Sessions cover the full arc of CWA implementation — from permit issuance and water quality standards development through impaired waters assessment, TMDL development, and enforcement — with dedicated time for emerging issues including PFAS and other contaminants of emerging concern, climate resilience, and the evolving legal landscape following recent Supreme Court decisions affecting the Act's scope and state certification authority.

PANEL DISCUSSION ON REGIONAL EFFORTS THAT COULD INFORM LARGER DIALOGUE ON PRIORITIZING NUTRIENT MANAGEMENT AND RESTORATION

The proposed panel would provide a discussion to address the "third wave" of nutrient policy, focusing on the administrative shift from simple point-source fixes to complex, multi-sector accountability. FIELD TRIP: TOUR OF THE UPPER SANTA FE WATERSHED

Attendees will travel to the Upper Santa Fe Watershed to see how the City is managing and protecting their source water. Transportation & lunch will be provided.

The City of Santa Fe and Santa Fe Watershed Association will provide a tour of the Santa Fe Municipal Watershed, closed to the public since 1932. This 4.5-mile hiking tour of the watershed includes views of the Nichols Reservoir, city drinking water infrastructure, and the Santa Fe River. The City of Santa Fe and Santa Fe National Forest have partnered to complete many source water protection and wildfire mitigation treatments throughout the watershed. The Santa Fe Watershed Association has championed education and outreach in partnership with the City of Santa Fe to teach watershed science, water conservation, and water quality topics for over 15,000 students in the 5th grade as part of the “My Water, My Watershed” program.

This tour does start at an elevation of about 7,500 ft and will have an elevation gain of approximately 500 ft. The hike will be up a closed dirt road for approximately 4.5-miles. As a note, it is monsoon season in Santa Fe, meaning that we typically have cloud build-up and sporadic, intense thunderstorms throughout the afternoon. The timing of this hike should be fine from 9:30 am to 12:00 pm, but we will encourage attendees to bring layers. Participants are encouraged to bring good walking shoes, a water bottle, a hat, wear sunscreen, a light raincoat, and potentially a light jacket as temperatures can shift quickly from hot to chilly.

THE DIGITAL AGE AND CLEAN WATER

New technology is reshaping how regulators protect water quality. Artificial intelligence can help states and utilities use data, detect contamination, predict harmful algal blooms, and improve treatment. At the same time, data centers, semiconductor manufacturing, and battery production/recycling can increase water demand and create wastewater and pollution risks. Cybersecurity is also essential as treatment plants and monitoring systems rely more on connected controls.
